### **INVITATION TO BID**

#### **FOR THE**

**Construction of Multi-Purpose Drying Pavement (MPDP) at Brgy. Cabaruan, Bacarra,  
Ilocos Norte**

The Provincial Government of Ilocos Norte through Trust Fund – LBC 130 intends to apply the sum of Four Hundred Sixty Thousand Pesos (Php460,000.00) being the Approved Budget for the Contract (ABC) to payments for the **Construction of Multi-Purpose Drying Pavement (MPDP) at Brgy. Cabaruan, Bacarra, Ilocos Norte**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Provincial Government of Ilocos Norte now invites bid for the **Construction of Multi-Purpose Drying Pavement (MPDP) at Brgy. Cabaruan, Bacarra, Ilocos Norte (BAC IN 2021-64)**. Completion of Works is *18 calendar days*.

Scope of Works includes; Earthworks; Sub Base and Base Course; Concrete Structure.

Bidders should have completed a SLCC similar to the Contract to be bid, within ten (10) years from the date of submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II (Instruction to Bidder).

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizen/sole proprietorship, cooperatives and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from BAC Office, Provincial Capitol, Laoag City and inspect the Bidding Documents at the address given below from *8:00 AM to 5:00 PM. Monday to Friday*.

A complete set of Bidding Documents may be acquired by interested bidders on **November 11 – December 1, 2021**, from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Hundred Pesos (Php500.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGeps) and the website of the Procuring Entity, provided that bidders shall pay applicable fee for the Bidding Documents not later than the submission of their bids.

The Provincial Government of Ilocos Norte will hold a **Pre-Bid Conference** on **November 19, 2021, at 2:00 P.M.** at **BAC Office, Provincial Capitol, Laoag City**, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat on **December 1, 2021 at 2:00 PM** at **BAC Office, Provincial Capitol, Laoag City**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

**Bid Opening** shall be on **December 1, 2021 at 2:00 PM, BAC Office, Provincial Capitol, Laoag City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Provincial Government of Ilocos Norte, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
